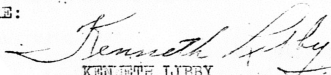
1. You are directed to proceed by air in the aircraft as indicated above at the proper time from Grenier Field, Manchester, New Hampshire, via the North Atlantic Route to the European Theatre of Operations, London, England, reporting upon arrival thereof to the Responsible Representative, USAAF, ATC Terminals of Arrival, British Isles, for further assignment and duty with the USAAF in ETO.
2. This is a PERMANENT change of station.
3. You will not discuss this movement even by shipment number except in the transaction of official business. You will not file safe arrival telegrams with commercial agencies while enroute to nor at domestic or overseas destinations.
4. From the time of departure from the continental United States until arrival at permanent overseas station, payment of per diem is authorized for a maximum of forty-five (45) days.
5. When an air travel status does not exist and it is impracticable for the Government to furnish sleeping accommodations and other quarters and/or rations in kind, the daily monetary allowance prescribed in Sec. II, GS, AR 35-4520, will be paid enlisted men.
6. Preparation for Overseas Movement of AAF Replacement Combat Crews, short title, FORM, dtd 1 April 1944, constitutes an integral part of this order.
